Participation Procedure

Exhibitors must complete the Exhibition Application Form (Form 1) and Exhibit List (Form 2) and submit them to **theSecretariat of Beijing International Automotive Exhibition via email (sales@hyexhibition.com)** by October 30, 2025. Along with the application form, exhibitors must provide two copies of their product list and product descriptions. Booths will be assigned in a fair manner based on the order of registration. Exhibitors are encouraged to register as early as possible.

Upon receiving the application form and exhibit list, the Secretariat, in collaboration with relevant departments, will review the exhibits. Once approved, the Secretariat will issue a Confirmation of Participation, the Exhibition Manual, and related materials.

After receiving the Confirmation of Participation from the Secretariat, exhibitors must remit the relevant fees to the designated bank and proceed with booth design and preparation as per the allocated exhibition space.

Technical Seminars and Exchanges

During the exhibition, exhibitors can apply to host seminars on new products, technologies, or processes based on their needs. Details are available in the Application Form for Meeting Rooms and Technical Exchanges (Form 3).

Booth Pricing

The standard booth follows international standards with aluminum alloy fram, three display walls, bilingual nameplates (Chinese/English), carpeted floor, two spotlights, one table, one trash can, and one 220V/5A power socket. The minimum area for a standard booth is 9 m². Non-standard booths (without any facilities) are priced at ¥1800 per m² for indoor spaces and ¥1000 per m² for outdoor spaces. These booths are designed and constructed either by the exhibitors themselves or by a commissioned designer. The minimum area for a non-standard booth is 36 m².
